

CPP31318 – CERTIFICATE III IN SECURITY OPERATIONS Crowd Controller Revalidation

This Crowd Controller Revalidation course is suitable for licensed security officers and crowd controllers who are required to renew their Queensland Security and/or Crowd Controller license.

After successful completion of this course you will have the knowledge and skills to re-apply for a Queensland Security license with the Office of Fair Trading.

Method of Delivery

3 day face-to-face training

This course is delivered from 8:30am until 5:00pm on selected days. The total duration of the in house training takes place over 3 days.

Self-paced training

This training is split into 2 components (theory and practical). Self-paced delivery allows the student to complete the theory portion online and complete the practical training in an inclass environment. Total duration of training to be undertaken within 6 (six) weeks.

Minimum Requirements for Eligibility

To be eligible for this course you are required to meet the following criteria:

- Hold a current Qld Crowd Controller License
- Be an Australian or New Zealand Citizen or Resident documented with a Passport,
 Citizenship Certificate or Green Medicare Card (Must provide at least 1 Document)
- Prove your identity documented with a Drivers License, 18+ Proof of Age Card, Keypass Card or Passport (Must provide at least 1 Document)
- 18 years of age or older documented with a Drivers License, 18+ Proof of Age Card, Keypass Card or Passport (Must provide at least 1 Document)

We are not CRICOS approved and do not train international students

Units of Competency

Upon successful completion of the course you will be provided with a Statement of Attainment for the following units of competency. To achieve this qualification you will be required to complete and demonstrate an understanding of the following 4 units of competency through written assessments, verbal assessments and practical display assessments and case scenarios.

Upon Successful Completion of this Course

The Office of Fair Trading require that these units are completed to renew your Crowd Controller License every 3 years with HLTAID001 – Provide Cardiopulmonary Resuscitation recommended for renewal every 12 months.

This course will also provide you with multiple opportunities to practice and present good communication skills, teamwork, problem solving, initiatives and enterprise, planning and organisation, self management, effective learning skills and information about the newest security law, legislation and security technology.

Price
